(Fred Marmon Survey); and running N 00° 09' 17" W, 5196.47 feet distance to the Northwest Corner of the parcel herein described; thence, S 88° 53' 50" E, 288.97 feet distance to the Northeast Corner of the parcel herein described; thence, S 01° 04' 10" W, 5470.15 feet distance to the Southeast Corner of the parcel herein described; thence, N 88° 50' 00" W, 171.95 feet distance to the Southwest Corner of the parcel herein described; thence, NORTH, 275.06 feet distance to the place of beginning of the parcel herein described, and containing 28.88 acres, more or less.

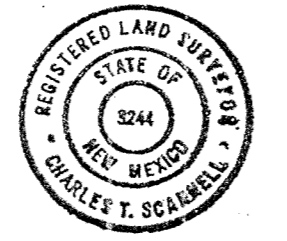
